### **Student Conduct Code for Transportation and Bus Route Schedule**

#### **INTRODUCTION**

Riding the bus is an important part of the school day for most Maysville Local School students. By working together, we can achieve the goal of safe and enjoyable transportation. Please take a few minutes to review this handbook with your child. This booklet has been prepared for parents and students in an attempt to clarify the position of the Maysville Local School Board of Education, school officials, and bus drivers regarding the laws and policies pertaining to pupil transportation. It is our hope that this information will help provide a congenial relationship between the bus driver and the student passengers. Transporting children safely to and from school is our main concern, and we feel we can expect your cooperation and support if you are completely informed about our transportation practices.

Maysville Local Schools will begin classes for the 2018-2019 school year on Wednesday, August 22, 2018. An enclosed transportation schedule is provided to give parents and students information about the approximate geographic area of bus travel, the bus drivers' names, and the bus numbers for all morning trips. High School, Middle School, Vocational School, and Parochial students will be picked up between the hours of 6:30 a.m. and 7:30 a.m.

## **STUDENT RESPONSIBILITIES**

### **BUS STOP & LOADING**

1. Be at the bus stop at least five (5) minutes ahead of time.
2. Wait for your bus in a safe place – away from the road.
3. Wait at the stop in an orderly manner – away from the road.
4. Stay clear of the bus until it comes to a complete stop.
5. If a student lives on the opposite side of a road from a bus stop, the student should go to the front of the bus and wait until the bus driver gives the signal to cross the road.
6. Check both ways for traffic before crossing.
7. Never go back to pick anything you drop or forgot.
8. Never cross the road in the rear of a stopped bus.
9. Walk quickly and quietly to your seat.

### **RIDING THE BUS**

1. Remain seated at all times.
2. Students are to be courteous by keeping their hands and feet to themselves and keeping the noise level down.
3. Keep hands, arms, and head inside the bus at all times.

### **DEPARTING THE BUS**

1. Remain seated until the bus comes to a complete stop.
2. Walk quickly and quietly while exiting the bus.
3. Exit the bus carefully, using the handrails.
4. Only depart at your scheduled stop.
5. At the bus stop, take ten (10) giant steps away from the bus to a safe zone.
6. If a student lives on the opposite side of a road from a bus stop, the student should go to the front of the bus and wait until the bus driver gives the signal to cross the road.
7. Check both ways for traffic before crossing and go to your safe zone.
8. Never go back to pick anything you drop or forgot.
9. Never cross the road in the rear of a stopped bus.
10. Go directly home.

## **STUDENTS' EQUIPMENT**

The Ohio Revised Code is quite clear as to transporting students' equipment. Band instruments, athletic satchels, books, lunch pails, backpacks, and all other articles carried by the students must be held in their laps. The bus driver cannot permit objects to be placed in the aisles, in front of the emergency door, at the entrance of the bus or anywhere that might endanger pupils or hinder the safe operation of the vehicle. If equipment is too large to be carried safely, the driver cannot transport it. Parents will have to make arrangements for transporting equipment that is too large to and from school (O.R.C. 3301.80.09).

## **FORBIDDEN CARGO**

The Ohio Revised Code and the Ohio Administrative Code spell out what cannot be transported on a school bus. A short list of forbidden cargo includes the following items:

- spectators (parents, brothers, sisters, or any visitors to school – transported people must be attending school)
- animals (dogs, snakes, insects, birds, etc.)
- dangerous weapons (knives, explosives, ammunition, guns, noxious gas, fireworks, brass knuckles, look-alike weapons, etc.)

The above listing is not meant to be all inclusive. It provokes an idea of what the law entails. Bus drivers have final say in determining the transport of questionable items. If there is a question of whether an article is “forbidden cargo”, please contact the Bus Transportation Department.

## **BUS CHANGE PROCEDURE**

Students may ride only their assigned bus. Students will **ONLY** be “picked up” and “dropped off” at their 1 assigned stop. Your assigned bus/stop will remain the same unless you move to a new address. The **ONLY** time a bus change can be made is if you move to a new address. You will then need to contact the Transportation Supervisor to arrange a permanent bus change to the new address.

If you have special circumstances (such as shared parenting, etc.) that require consideration, please contact Assistant Superintendent, Joe Daniels, for an appointment to discuss your circumstances. You may call the District Office at 740-453-0754 to schedule an appointment.

## TRANSPORTATION CODE OF CONDUCT

School bus transportation is a privilege and not a right.

A violation of any rule will result in disciplinary action.

1. **Students will be expected to demonstrate respect toward all bus drivers at all times.**
2. Students must cooperate with the bus driver. The driver is in charge and may assign seats, etc.
3. **Students are to be courteous.**
4. Students shall not by use of violence, force, noise, coercion, threat, harassment, intimidation, fear, passive resistance or any other conduct, cause, attempt, or threaten to cause the disruption of transportation services. Students shall not urge other students to engage in such conduct for the purpose of causing, attempting, or threatening to cause the disruption of transportation.
5. **Students shall not block the entrance or exit of any school bus or bus aisle way.**
6. Students shall not set fire or attempt to set fire to, or damage or attempt to damage, or deface or attempt to deface a school bus.
7. **Students shall not make, by telephone call, letter, or other means, a threat to damage or destroy school property or to disrupt school transportation.**
8. Students shall not activate or attempt to activate any emergency alarm system in the absence of an emergency.
9. **Noise on the bus shall be kept to a minimum. Continuously making noise or acting in a manner so as to interfere with a driver's ability to execute his/her responsibilities may result in disciplinary action.**
10. Students should always remain seated while the bus is in motion.
11. **Eating, drinking, smoking, and littering are not permitted on the bus. Students must help keep the bus clean.**
12. Students are not permitted to throw anything inside or out the bus window.
13. **Students are to keep their head and hands inside the bus. Windows will not be opened without the permission of the bus driver.**
14. There must be absolute quiet at all railroad crossings and other places of danger, as specified by the driver.
15. **Students are not permitted to bring large or bulky items for class projects on the bus due to limited space. These items should be taken to school by the parent/guardian.**

16. Animals cannot be transported on a school bus, in conformance with state regulations.
17. **Students shall not cause or attempt to cause damage to school property or steal or attempt to steal school property.**
18. Students shall not cause or attempt to cause damage to private property of students, school personnel, or other persons.
19. **Students shall not act or behave in such a way as could cause physical injury to a student, the driver, or other employee of the school district.**
20. Students shall not use, possess, handle, transmit, sell, or conceal any object that can be classified as a weapon or dangerous instrument.
21. **Students shall not possess, use, transmit, conceal or show evidence of consuming or using tobacco, narcotics, alcoholic beverages, or look-alike drugs.**
22. Students shall comply with all requests and directives of bus drivers during any period of time when the student is properly under the authority of the driver.
23. **Students shall not use profane, obscene, demeaning, or derogatory language, either written or verbal, in communicating with the driver.**
24. Students should ride the regularly assigned bus and unload at the regular stop.
25. **Students will not leave school grounds between bus transfers.**
26. Students shall not board buses to which the students are not assigned except with the express permission of the school principal. Written permission must be given to the driver as the student boards the bus. Students under suspension, expulsion, or emergency removal are not permitted on school buses without the express permission of the school principal.
27. **Students shall not forge the writing of another, or falsely use the name of another person, falsify items, dates, addresses, or other data on school related correspondence.**
28. Any student who has knowledge about specific incidents of code of conduct violations, and deliberately withholds information from school authorities will be subject to disciplinary actions.

29. **Students shall not engage in any unwanted visual, verbal, or physical conduct of a sexual nature.**
30. Disorderly conduct or safety violations are a sufficient reason for refusing bus transportation.
31. The bus is an extension of the classroom and as such, the same rules apply.
32. Students shall not use bus ramp between the elementary and 6/12 buildings.

### **PARENT INFORMATION AND REponsIBILITES**

School bus transportation is a privilege and not a right. The bus driver is the sole authority on the bus while students are being transported. It is most important that each student cooperate with the bus driver and practice safe bus riding habits at all times.

1. Students are expected to conduct themselves in a proper manner at school bus stops. Behavior must not threaten life, limb, or any individual. The District will not enter into neighborhood disputes involving parents and/or students concerning matters that take place prior to the student boarding the school bus or after the student has disembarked from the bus on his/her way home. Students must leave unloading areas as soon as possible.
2. Students will ride only assigned school buses in seats assigned by the bus driver, and will board and depart from the bus at assigned bus stops.
3. A permanent transfer to another route or bus stop for morning pick-up and/or afternoon drop-off will only be made upon the approval of the transportation supervisor.
4. Students shall cross all streets at least ten (10) feet in front of the school bus and after the driver has signaled the student that it is all right to do so.
5. For the safe operation of the school bus, noise on buses shall be kept at a minimum with students speaking in reasonable conversation voices. Students must be quiet at railroad crossings and other danger zones as designated by the bus driver.
  - a. Students are not allowed to bring their own radios or tape recorders on the bus.

- b. The transportation supervisor must approve both the use of a bus AM/FM radio and the station or programs which students listen to.
7. Students shall remain seated while the school bus is in motion and keep all parts of their bodies inside the bus. Students shall keep main bus aisle clear at all times.
8. Students shall not throw items inside of the bus or out of bus windows or doors and should not hold anything so that it extends out of the bus window.
9. Students must not tamper with or open a school bus emergency door unless directed to do so by the bus driver.
10. Selling or trading items on the school bus is prohibited.
11. Eating, drinking, or littering is not permitted on a school bus.
12. Possessing, using, or selling tobacco is strictly prohibited on a school bus and the appropriate law enforcement agency will be notified.
13. Abusive, profane, or inappropriate language is not permitted.
14. The following cargo is forbidden on school buses: pets, alcoholic beverages, illegal drugs, look-alike drugs, ammunition, explosives, firecrackers, firearms, knives, look-alike weapons, water dispensers, electronic devices, pagers, glass containers, laser pointers, or any other dangerous materials or objects. If there is a question on the transportation of a particular item, the transportation supervisor should be consulted.
15. Materials that could be dangerous that are used for student projects or physical education classes should be transported by parents to and from school, i.e. live creatures, arrows, or any other forbidden school bus cargo.
16. Students will remain on their original bus if it is a shuttle bus going to his/her school of attendance.
17. Students waiting for shuttle buses must wait in areas assigned by the principal.
18. Students will not leave school grounds between bus transfers.
19. Parents shall not use bus ramp between elementary and 6/12.

Parents can contribute to the safe and efficient transportation of their children in the following ways:

1. See that the child(ren) is at the proper bus stop at least five (5) minutes before the scheduled time. Drivers are instructed not to run ahead of schedule, and are not required to wait for children, as all children farther along the route would be forced to wait that much longer. On some roads, waiting also causes longer lines of cars behind the bus, creating a traffic hazard.
2. See that the children ride their assigned buses, and leave buses at their correct stops.
3. Parents share the responsibility of seeing that the children are orderly while awaiting a bus or after unloading on the bus route.
4. Parents will be responsible for any damage to a bus by their child/children.
5. Parents should assist the school program by teaching their child/children traffic safety procedures and proper conduct.
6. Parents are not allowed on the school bus except with authorization from the transportation supervisor.
7. Parents of vocational and parochial students are responsible for the drop off and pick up of their student/s when Maysville Local School District is not in session. The bus will leave the HS/MS lot at 7:35 a.m. and return students to the lot at 3:05 p.m.
8. Preschool students are seated in the front of the bus. We do not allow a preschool student to get off the bus at his/her home unless an adult is at the bus stop to meet the student. If no adult is at the bus stop, the student will stay on the bus and go to Extended Care where they can be picked up by the parent.

## **DISCIPLINE PROGRAM ELEMENTARY/MIDDLE SCHOOL/HIGH SCHOOL**

The bus driver will keep a Bus Incident Report Log on each student that violates the student conduct code for transportation. The date, codes violated, and comments will be recorded for each step. Below is the ten-step program for discipline that will be followed:

- Step 1 Verbal warning by driver
- Step 2 Other driver action (example-assigned seat)
- Step 3 Parent contact by driver/supervisor (phone or letter) plus other driver/supervisor action
- Step 4 Student conferences with principal/written notice, plus principal action (example-detention)
- Step 5 Bus Slip – one day bus suspension
- Step 6 Bus Slip – two days bus suspension
- Step 7 Bus Slip – three days bus suspension
- Step 8 Bus Slip – five days bus suspension
- Step 9 Bus Slip – ten days bus suspension
- Step 10 Bus Slip – loss of bus riding privilege for remainder of school year

Anything considered to be a severe disruption (such as fighting, extreme disrespect to driver, endangering themselves or others, vandalism, etc.) will result in a School Bus Incident Report (Bus Slip) for administrative action to be written. The student will move to step 5 (or above) on the discipline plan. If a disruption results in the bus being stopped to correct it, or if a student is removed from a bus for being disruptive, additional bus suspension time may be added.

## **PROCEDURE TO CLOSE SCHOOLS IN CASE OF WEATHER EMERGENCY**

The following information is provided to assist you in determining if school has been cancelled.

1. Local radio stations (WHIZ, WYBZ, and WCVZ) will broadcast school closing bulletins when emergency weather conditions exist. We will also utilize the all-call system to notify our families of any cancellations or delays. Also the district web site will post any school closing bulletins. The web site address is: [www.maysville.k12.oh.us](http://www.maysville.k12.oh.us). Every effort will be made to have these bulletins on the air by 6:15 a.m., or as early as possible when a weather emergency has developed.

2. If the radio stations & web site announce no bulletin, it should be assumed that Maysville Local School District would be in session.
3. All people are urged to listen to the radio broadcast or check the district web site and are asked not to call any school personnel or the radio station. Any unnecessary phone calls tie up telephone lines when they are needed during the weather emergency.
4. If the Maysville Local School District has already opened for the day and a weather emergency occurs during the school hours, it may be necessary to send students home early. Radio stations will be notified if this happens and will broadcast this information and it will also be posted on the district web site. Every effort will be made to notify families through our all-call system.

### **EXTRA CURRICULAR TRIPS**

Bus rules apply to every trip under school sponsorship. Pupils shall respect the wishes of the chaperone, as well as the wishes of the driver. If the driver and the chaperone cannot control students, the trip will end.

Students will be returned to the school and disciplinary action will be taken.

1. Driver, coach, teacher, and/or chaperone must enforce this document.
2. Violations must be submitted to driver.
3. The most severe level of punishment for any category will be used for any offense.

### **PROCEDURES**

1. Principals can request a bus driver to appear for a conference.
2. **Vocational school student information regarding any offense will be forwarded to the building of attendance principal.**
3. Parochial school student information regarding any offense will be forwarded to the building of attendance principal.
4. **Suspension of handicapped pupils shall be in accordance with the law.**
5. A suspension from bus riding privileges means all buses, but does not include suspension from school; this means that attendance at school is still mandatory.
6. **Surveillance with videotaping equipment may be conducted on school buses.**

\* In all cases (K-12) listed above, when circumstances warrant, the principal has the option to select another level of punishment subject to review by the Maysville Local Administrative Team.

- Expulsion is the removal of a student for a period of up to eighty (80) school days or the number of school days remaining in the semester or term in which the incident that gave rise to the expulsion takes place, whichever is greater. If at the time of expulsion, there are fewer school days than the number of expulsion days, the Superintendent has to option to: apply the remaining period of expulsion to the following semester or school year, or impose a community service requirement beyond the end of the school year in lieu of applying the suspension or expulsion into the next school year. However, community service as an alternative to expulsion cannot be used when a firearm is involved.

### **(Subject to change)**

The Board of Education designates all bus routes and stops. Routes are planned to ensure the maximum efficiency of the district's vehicles and stops are designed to ensure maximum safety of students. By law, the district is required to: Limit the number of bus stops. Designate "depots" at which children can gather for "pick-up" or "drop-off". Ensure that stops are "sufficiently" removed from curves.
